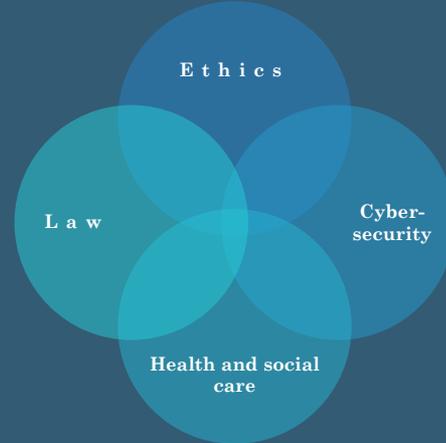

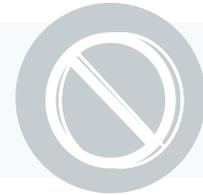

# Joined Up Data Equals Better Care



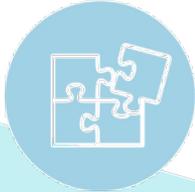
Turning the wealth of health and social data into *insights for better public health and personalised care* is critically important for society

Yet *data access and insights are hampered* by slow, manual governance processes that are error-prone, time consuming and not easy to repeat

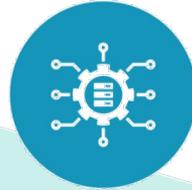


With increasing data volumes, complexity, and need for fast collaborative solutions, *new approaches to data governance* must be found

# A Social Data Foundation



We are establishing a Social Data Foundation that aims to improve health and social care by ***accelerated access to linked data*** from citizens, local authorities and healthcare providers



We will deliver a ***smart data management platform*** that helps automate legally compliant and ethical governance between health and social care data providers and analysts



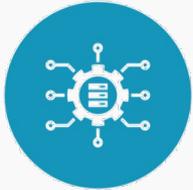
We are a ***partnership between UoS, UHS and SCC*** to oversee the creation of the platform and the Foundation itself

# Driven by Unmet Care Needs



**Users**

- Seamless patient journey
- Digital divides, health inequalities and literacy
- Co-creation and social licence from citizens
- Co-creation and acceptance by healthcare workers



**Systems**

- Progressive digitisation of systems through IoT and Twins
- Advancing medical interventions and pathway configuration
- Continuously evolving collaborative governance
- Sustainability and performance



**Data**

- Data silos and lack of discoverability (clinical, social, environment, operational)
- Slow access to data
- Lack of assurance over data-related risks
- Disconnection from citizens

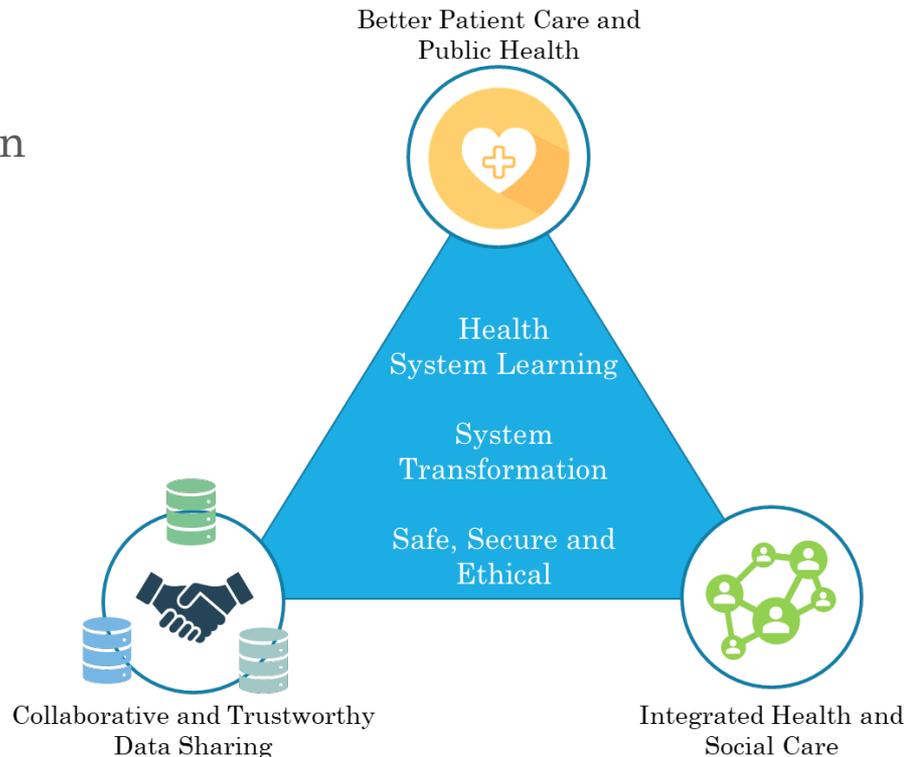

# Solution: A Data Foundation

A new **data institution** for multi-party data sharing between the Council, Hospital, University called the

*Social Data Foundation*

- that builds on the data foundations framework for good data governance together with strong citizen representation and contract law

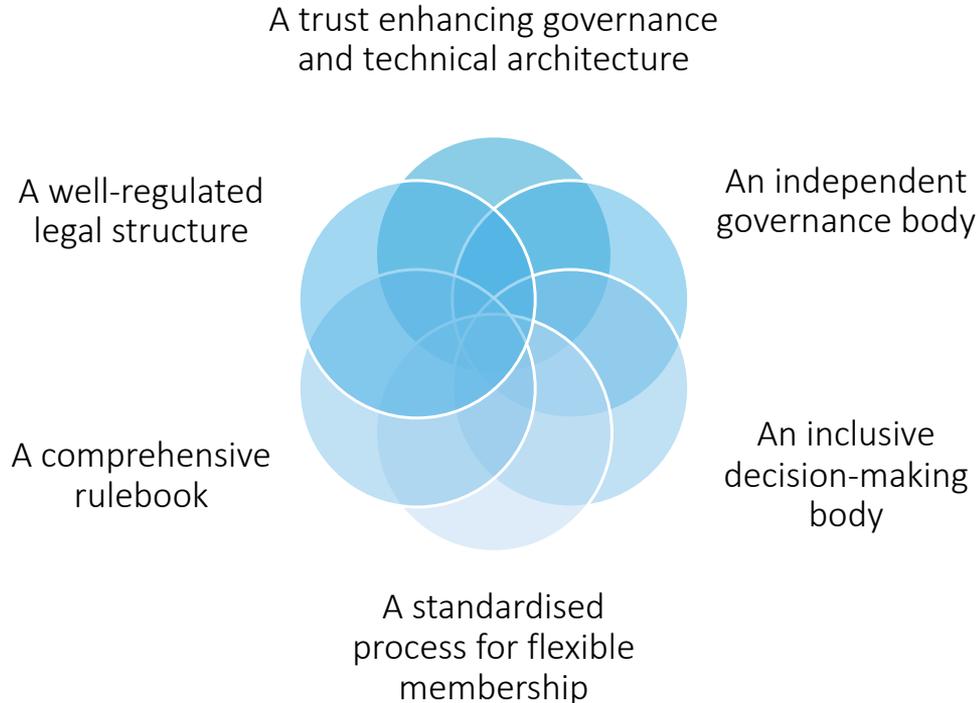
'Data institution' describes:

*“organisations whose purpose involves stewarding data on behalf of others, often towards public, educational or charitable aims”*,

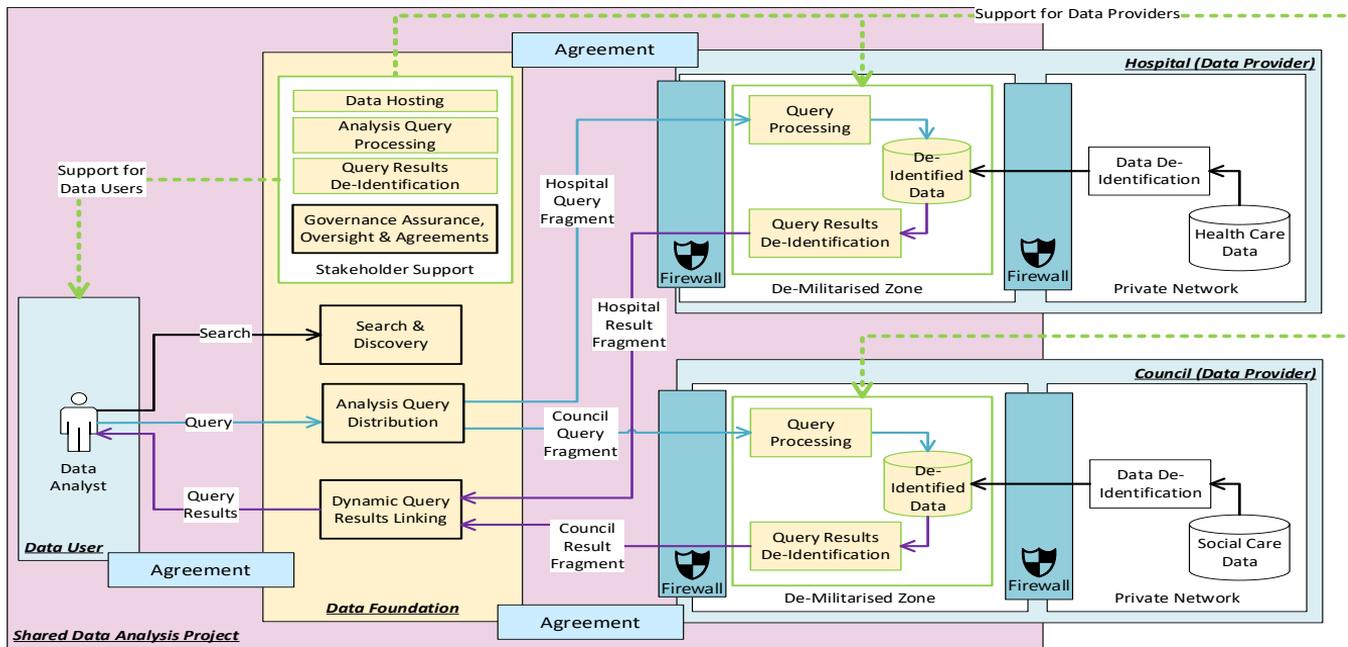

# Better Policy, Compliance + Smart Governance Technologies



**Data Foundation Architecture**  
(distribution of function)

- Automated risk management
- Ownership and rights management
- Security and privacy controls
- Dynamic data linking

# The principal ways the Data Foundation could accelerate data sharing

**Better data discoverability**

**Local** solutions with **national** leadership

**Empowering citizens** to co-create and participate in systems transformation

**Greater assurances** that best practice data governance is followed

**Faster** ethical oversight and information governance
